



## **SPOTLIGHT ON**

The DISRUPT (ANR JCJC) project, due to recent public debates on the role of social media, is aiming to mobilize innovative data collection and automated content analysis techniques with state-of-the-art econometric methodologies to provide empirical analysis on the use of these platforms by politicians, non-profit organizations, businesses, workers and trade unions and examine their multifaceted effects on an extensive set of political and economic variables.

While wealth and income inequality have increased in many countries in recent decades, European welfare states have come under pressure amid persistent economic difficulties and increasing globalization. Through a Franco-German perspective, EQUITAX (ANR) intends to contribute to this issue by studying the most effective socio-fiscal instruments to fight against these inequalities. To this objective, EQUITAX will develop a pioneering and comprehensive analysis on the link between taxation and inequality, combining applied macroeconomic, theoretical and micro econometric approaches.

The ecological transition has important consequences on the demand for minerals. The objective of the ArtiMinDev project (ERC Consolidator), is to map the opening/closure of artisanal mines in sub-Saharan African countries over the 2000-2022 period with accurate location information to analyze the impacts of artisanal mining in these countries concerning income, violence, environmental degradation and health, as well as on internal migration.
